13 Order to hold [^{F21}investigation].

- (1) This section applies where, on an application by or under the authority of the Attorney-General, the High Court is satisfied as respects a coroner (“the coroner concerned”) either—
 - (a) that he refuses or neglects to hold an inquest [^{F22}or an investigation] which ought to be held; or
 - (b) where an inquest [^{F23}or an investigation] has been held by him, that (whether by reason of fraud, rejection of evidence, irregularity of proceedings, insufficiency of inquiry, the discovery of new facts or evidence or otherwise) it is necessary or desirable in the interests of justice that [^{F24}an investigation (or as the case may be, another investigation)] should be held.
- (2) The High Court may—
 - (a) order an [^{F25}investigation under Part 1 of the Coroners and Justice Act 2009] to be held into the death either—
 - (i) by the coroner concerned; or
